Climate School – Terms of Use (site Edapp)

These terms of use (the "Terms of Use") are entered into by the designated person registered on the EdApp Platform (hereinafter the "User", "Your", or "You") and AXA Climate, ("AXA Climate", "We", "Our", or "Us"), a French simplified joint-stock company ("société par actions simplifiée") with its registered office at 61, rue Mstislav Rostropovitch 75017 Paris, France, registered with the Registry of Commerce and Companies of Paris under the number 493 363 378. These Terms of Use govern the conditions under which AXA Climate provides a training on sustainable transition (the "Climate School") consisting of educational online courses (the "Online Courses") hosted and accessible on the EdApp platform ("EdApp Platform"), available at: https://web.edapp.com/#home. These Terms of Use supplement the terms of service of EdApp Platform available at: https://support.edapp.com/terms-of-service ("EdApp Terms of Service").

1. Acceptance of the Terms of Use and changes

Any access, view, and use of the Online Courses, is subject to compliance with all these Terms of Use. By clicking on the "I accept the Terms of Use" button, You acknowledge that You have read and understood them and are confirming Your agreement to be bound by the current version of these Terms of Use. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS OF USE, YOU ARE NOT AUTHORIZED TO ACCESS TO, VIEW OR USE THE ONLINE COURSES.

AXA Climate reserves the right to add, modify or remove and more generally update at any time, all or part of these Terms of Use. Any material change of these Terms of Use shall be notified to You by e-mail and/or by posting on AXA Climate's hosting page on the EdApp Platform. You shall read the new version of the Terms of Use. By clicking on the "I accept the new version of the Terms of Use" button, You acknowledge that You have read and understood them and are confirming Your agreement to be bound by the new version of the Terms of Use. The last version of the Terms of Use's date is specified hereinabove for Your reference.

Each User shall have a username and a password. The username and password are personal and cannot be shared with other users.

You are solely responsible for maintaining the confidentiality of Your username and password and for all activities that occur under Your username and password. A free of charge access is provided (i) to Users that are individuals and considered as consumers under French law or (ii) to Corporate Clients that wish to make the Climate School available to their employees within the limit of the first ten (10) Authorized Users.

Except if You have entered into a separate agreement with AXA Climate, these Terms of Use constitute the entire agreement between You and AXA Climate with respect to Your access and use of the Online Courses, superseding any prior agreements between You and AXA Climate regarding Your access and use of the Online Courses.
